COMPETITION OVERVIEW:

The **2025 Magic City Ice Classic** will be conducted in accordance with the rules and regulations of U.S. Figure Skating, as set forth in the [current rulebook](#), and/or current [Compete USA Handbook](#) as well as any pertinent updates that have been posted on the U.S. Figure Skating [website](#).

This competition is open to all eligible, restricted, reinstated or readmitted persons as defined by the Eligibility Rules.

Skaters must be a currently registered member of a U.S. Figure Skating member club, Learn to Skate USA® member, a collegiate member or who is an individual member in accordance with the current rulebook. For non-U.S. citizens, please refer to the [rulebook](#) for more information.

SERIES INFORMATION:

The **2025 Magic City Ice Classic** competition is a designated **Excel Series** competition for the 2025 Excel Series. As an Excel Series event, skaters entered in the Series at eligible levels will earn points for their placement.

Skaters must be registered for the Excel Series prior to competing at designated competition: **The deadline to register for the Excel Series is March 1st, 2025**, or prior to your first competition, whichever is earlier.

MAGIC CITY ICE CLASSIC 2025 INFORMATION AND REGISTRATION:

Entries will be accepted via the [EMS Competition Portal](#) with credit card only. Each transaction will include a 3% credit card fee. **Online registration opens on February 2, 2025 at 12:00 PM (noon) EST** and closes on March 16, 2025 at 11:59 pm EST. Skaters wishing to register for the competition will need their U.S. Figure Skating member number and password. Registration may close earlier in case event reaches full capacity prior the set deadline.

REFUND POLICY:

No refunds will be granted under any circumstances, including medical, unless the competition or an event is canceled. Online processing fees are non-refundable. Payment of any fees will be required before the skater is allowed to participate in practice ice or events.

Pre event communication: Communication channel will be established to inform skaters and coaches about the competition environment including current Covid-19 restrictions, venue maps, safety plans or any other urgent information including local, national or USFS restrictions. This competition will use Virtual Program (under BFSC website) to deliver all material including start orders and results.

ELIGIBILITY

Singles: Excel and Well-Balanced Events:

- Skaters must meet at least the minimum singles test requirements for the event’s level. A skater’s singles test level may be higher than the minimum requirement.
- Skaters may skate up one level higher than their minimum test requirement allows.

- Skaters may not register for an event level lower than allowed by their competitive floor. An athlete's competitive floor is set by one of the following scenarios:
 - o If an athlete has a paid EMS series application for the NQS series, the event level registered for in the most recent NQS will become the lowest level they may compete at in any U.S. Figure Skating sanctioned event.
 - o If an athlete has a paid EMS series application for the Excel Series, the event level registered for in the most recent Excel series will become the lowest level they may compete in any Excel event. For Well-Balanced and Specialty events the skater will be permitted to register at one level lower than the "floor" set by their excel series entry.
 - o If an athlete has never had a paid EMS series application in the NQS or Excel series, the athlete may select their level based on their goals and technical skills as long as the minimum test requirements are met.
- Skaters are not permitted to enter an Excel free skate and a Well-Balanced free skate event at the same competition (example: Juvenile Girls Free Skate and Juvenile Girls Excel Free Skate). However, they are permitted to enter an Excel and a Well-Balanced event of different types such as a short program (if stand-alone event option), specialty or showcase events (example: Intermediate Women Short Program and Intermediate Women Excel Free Skate).

All other singles and partner events (such as Adults, Pairs, Ice Dance):

- Skaters must meet the minimum test requirements for the events level, but not exceed the maximum permissible test requirement.
- We will not be accepting requests for adult skaters to skate in Excel or Well-Balanced Events. Adult Skaters will compete in designated adult events.
- Skaters entering pre-juvenile and lower events will be divided as closely as possible by age should the number of entries warrant more than one group.
- Boys and girls may be combined to make an event, except for standard track short programs and free skates

COMPLIANCE:

COACHES:

To be an eligible coach at a nonqualifying competition, coaches must meet the applicable compliance requirements and verified by U.S. Figure Skating. Coach compliance falls into two categories, Coach Compliance (includes choreographers) and Learn to Skate USA[®] Instructor

Compliance. Details regarding compliance requirements can be found [HERE](#). All compliance requirements must be met at the time of check-in to access the competition, no exceptions.

Coaches of foreign athletes: If you are a coach of a foreign athlete only, you are not subject to U.S. Figure Skating coach compliance and will only be asked to provide a letter of good standing for the federation your athlete represents.

TEAM SERVICE PERSONNEL:

Teams are permitted a maximum of two team service personnel. Team service personnel must have a current U.S. Figure Skating membership, a green lighted background check and completed SafeSport™ Training. All compliance requirements must be met at the time of check-in to access the competition, no exceptions. Team service personnel is defined as those indicated as a team manager and/or team service personnel planning to attend the competition with the team.

MANDATORY ATHLETES:

Athletes age 18+ as of the competition start date who will be competing on a team (i.e., synchro, ice dance, pairs, shadow dance, theatre, etc.) with at least one Minor Athlete must complete SafeSport™ Training.

Minor athletes who turn 18 mid-season are encouraged to seek parental consent to take the online SafeSport™ Training early to avoid any disruptions in their ability to participate as the training is required upon turning 18. The athlete will not be compliant until they have completed the training and their Members Only portal reflects completion. Please email skatesafe@usfigureskating.org for instructions or questions regarding parental consent.

FOREIGN SKATERS:

Non-U.S. skaters intending to register for this competition must set up a non-member account prior to registering for the competition ([click here for HOW TO](#)). This can be done by choosing the “Non-Member? Create Account” option on the [Members Only](#) login page.

TEST CREDIT:

Skaters meeting the requirements may register to receive test credit during their event at the competition. (Open Juvenile- Juvenile through Senior, Adult Silver- Masters Jr/Sr only). **New this year, registration for Test Credit will be made available through EMS until the competition registration deadline March 16, 2025. After this date, a skater may still register for test credit by contacting the competition Chair, but this must be done *at least three days prior to the competition*.** A fee of \$25 will be charged at the time of registration through EMS which covers the cost of the test credit packet and completion of the forms during the competition. Requests for Test Credit after the “late deadline” are subject to a \$25 late fee. Once you have registered and paid, please pick up your test credit packet at the registration desk and return your portion of the completed forms ***no later*** than 1 hour before your event begins. After your event, the Chief Accountant will finalize your forms which must be picked up at the registration desk prior to the end of the competition. It is the skater’s responsibility to submit these forms to the skater’s home club test chair for registration with USFSA within 14 days of completion of the competition.

IJS CRITIQUES

Individual IJS critiques will be available for **Well Balanced Juvenile through Senior level Free Skate events**. Group IJS critiques for Preliminary level and below are also planned for skaters, parents, and coaches during the competition. Critiques are offered ***free of charge*** to registered competitors. Information regarding registration as well as the time and location of critiques will be available after the competition schedule is released and will be sent to competitors via competition email.

SCHEDULE AND EVENT CHANGE REQUESTS:

Competitors may be scheduled **on any day or time** for the announced date of the competition. The competition and practice ice schedule will be available after the close of entries as soon as all entries are finalized. All participants will be notified via email once available and will be visible within the [EMS Competition Portal](#). The Birmingham Figure Skating Club reserves the right to divide an event, limit the number of entries, hold an event with only one entry, and cancel an event with only one entry. ***Prior to closing entries, there will be no information about the schedule or pre-plan of the schedule available.*** The competition schedule is created by the Chief Referee and is based on availability of officials

and ice time. As a result, event and schedule changes are not easily made after the close of entries and once schedule preparation has begun. ***Please check your event entries carefully for errors prior to the close of registration and notify organizers of any changes so that any necessary changes can be made before preparation of the schedule begins.***

Event change requests will be subject to a \$25.00 change fee which will be automatically added to a skater's cart once the event change is completed.

FACILITIES:

The competition will be held at the **Pelham Civic Complex and Ice Arena, 500 Amphitheater Road, Pelham, AL 35124**. The twin surface facility measures 200' by 85' with rounded corners and hockey barriers and the main surface's seating capacity is over 3,000 spectators. For directions, visit www.pelhamciviccomplex.com. The snack bar will be open during the competition. Visiting vendors will also offer skating and non-skating related products. Admission to the 2025 Magic City Ice Classic competition is free.

LIABILITY:

U.S. Figure Skating, Learn to Skate USA®, the Birmingham Figure Skating Club and the Pelham Civic Complex accept no responsibility for injury or damage sustained by any participant in this competition. This is in accordance with Rule 1600 of the official U.S. Figure Skating Rulebook.

LOCKER ROOMS:

Locker rooms and changing areas will not be available this competition. All athletes are expected to arrive at the arena ready (costumes, hair, make-up etc.). Athletes will be provided with an area to put skates on but changing will not be permitted in these spaces.

U.S. FIGURE SKATING TRAVEL POLICY:

All travel must strictly adhere to Two-Deep Leadership requirements. An Adult Participant cannot transport a Minor Athlete one-on-one and Two-Deep Leadership requirements must be adhered to at all times during In-Program travel, by transporting at least two minors or a second Adult Participant. An Adult Participant cannot share a hotel room or other sleeping arrangement with a Minor Athlete(s). OFFICIAL NOTICES:

An official bulletin board will be maintained virtually on the Birmingham Figure Skating Club website as Virtual Program. All starting orders and results will be posted online only. Link to this information will be provided for each attendee.

It is the responsibility of each competitor, parent, and coach to check the bulletin board frequently for any schedule changes and/or additional information.

Skaters are requested to arrive 60 minutes, (1 hour) prior to the scheduled time of their event. A tentative schedule of events will be posted before the competition. Events may run up to 30 minutes early at the discretion of the Chief Referee.

EMS MUSIC UPLOAD:

DEADLINE: April 19, 2025 11:59 PM EST

A \$75.00 LATE FEE WILL APPLY

Competitors participating in events with music are required to upload their music to [EMS Competition Portal](#) no later than **April 19, 2025 11:59 PM EST**. After this date, skaters will be locked out of this feature and subject to a **\$75.00 late fee**. The late fee will automatically be added to each skater's cart who doesn't meet this requirement by the deadline. Uploading the incorrect music without correcting it prior to the deadline is also considered a failure to meet the deadline. **Due to the additional work caused by failing to meet this deadline, late fees will not be removed under any circumstances.** All fees must be paid prior to receiving the skater credential onsite.

All music must meet the following criteria. If you have questions about what format you have, please contact your coach and get a new version of your music that meets the criteria listed below.

MUSIC CRITERIA:

- File Format: MP3
- Bit Rate: 192 kbps or higher and Sample Rate: 44,100 kHz
 - This will be verified by the music chair and they may request you upload a corrected file.
- Leaders and trailers (the silence or "dead space" before and after the actual start and end of the program music) may not exceed two (2) seconds. We prefer that there be NO leaders or trailers at all. Excessive leaders and trailers may disrupt the playing of the music during competition.

Competitors must also bring a copy of their competition music on CD or digital copy as a backup in case of technical difficulties and must be available rink side during the competition.

Only CDs (standard CD-R format only) will be accepted for backups and must be clearly marked with the competitor's name, event, and running time.

EMS PLANNED PROGRAM CONTENT (PPC):

DEADLINE: April 19, 2025 11:59 PM EST

A \$75.00 LATE FEE WILL APPLY

Competitors participating in IJS events are required to submit PPC in [EMS Competition Portal](#) no later than **April 19, 2025 11:59 PM EST**. After this date, skaters will be locked out of this feature in EMS and subject to a **\$75.00 late fee**. PPC will no longer be able to be added through EMS after the deadline passes and must be entered manually by the LOC. The late fee will automatically be added to each skater's cart who doesn't meet this requirement by the deadline. **Due to the additional work caused by failing to meet this deadline, late fees will not be removed under any circumstances.** All fees must be paid prior to receiving the skater credential onsite.

JUDGING SYSTEMS:

IJS: The International Judging System (IJS) will be used for the following events:
Excel Free skate Pre-Preliminary – Senior and all Plus levels, Well Balanced Singles Pre-Preliminary – Senior, Adult Pre Bronze – Masters Jr/Sr Free skates, Short Programs Open Juvenile and Juvenile through Senior.

6.0: The 6.0 Majority Judging System will be used for: Compete USA events, Aspire Free Skate, Adult Beginner and High Beginner, Athlete Development events and Compete USA Specialty events.

CJS: The Component Judging System (CJS) will be used for all Showcase events.

Judging systems have been specified in the chart of offered events listed previously in the announcement. In case links to event requirements conflict with latest USFS regulations, the current (latest) rulebook requirements will be followed.

GOVERNING COUNCIL:

We will implement requirement changes approved at the May 2024 [U.S. Figure Skating Governing Council](#). Please check our website and the U.S. Figure Skating website and [Technical Notifications](#) page for updates.

LIABILITY:

U.S. Figure Skating, Birmingham Figure Skating Club, and The Pelham Civic Complex accept no responsibility for injury or damage sustained by any participant in this competition. This is in accordance with Rule 1600 of the official U.S. Figure Skating Rulebook.

ONSITE REGISTRATION:

Onsite registration will open on May 2, 2025 at the start of the first practice ice session and close at the completion of the final event. The registration table will be clearly marked and located adjacent to the entrance of the rink.

By registering for this event, attendees acknowledge the policies and agree to following them. **All skaters are also required to sign waivers by U.S. Figure Skating through EMS registration.**

If you are participating in a role requiring compliance, please be sure to [download or print your compliance card](#) to verify your compliance status on-site, if requested. If you believe your compliance card does not accurately reflect your compliance status, please contact skatesafe@usfigureskating.org at least 2 business days prior to the competition for assistance.

Please register promptly upon arrival. Plan to arrive approximately 1 hour prior your event start time. Events may run up to 30 minutes early at the discretion of the Chief Referee.

Sales: We will sell practice ice sessions in advance (pre-purchase during registration window, click practice ice button on [EMS Competition Portal](#) after you have completed registration). After the schedule of competition is published, skaters can select pre purchased sessions. After selection window closes, we will open additional open practice ice sales. All practice ice will be available for purchase online only through the [EMS Competition Portal](#). A timeline for practice ice sales periods will be available for viewing on the competition information page of your [EMS Competition Portal](#). Athletes will be notified about the practice ice selection starting/ending times and additional practice ice sales openings via email. All skaters are encouraged to purchase practice ice through EMS on their mobile devices/computers and sales will remain live through the competition depending on ice availability.

Unofficial Practice Ice: Please note that all practice ice will be Unofficial Practice Ice and no music will be played during sessions.

Earbud/headphones: Earbuds and wireless headphones/other music devices will not be allowed on practice sessions or warmups associated with any events in this competition.

PHOTO/VIDEO:

Professional video and photography sales services will be provided during the competition. Events may be live-streamed and attendees will be notified separately how to access live streaming if available. Attendees will be notified about the photography/video vendor at a later date. Event video is not included in entry fee.

For the safety and welfare of the skater, personal photography and videography will be permitted in the stands only and is restricted to hand-held/battery operated equipment (no tripods.) Flash photography is strictly prohibited in the ice arenas and stands. No one will be permitted to obstruct the view of other seated spectators by standing in front of or hanging over the plexi-glass barriers or to film at alternative ice entrances. To comply with local fire safety codes, all aisles within the stands must also remain clear. Non-compliance with this policy or refusal to comply immediately with requests from event officials will result in the violator being escorted out of the rink.

Note, per U.S. Figure Skating policy, photographing and/or recording of anyone other than your own skater is strictly prohibited as stated in the Basic Ice Usage and Skater Etiquette Information document found in the Club Resource section of Member's Only on USFS website.

AWARDS:

Medals will be presented to the 1st, 2nd, 3rd, and 4th place winners in each competition event. Each singles event will be awarded separately. Team events will have award for each team member.

Award ceremonies will be conducted approximately 20 minutes after event results are official. Award podium will be in the lobby area.

VOLUNTEER INFO:

Birmingham Figure Skating Club requires members to offer mandatory annual 10 hours of volunteering for club events. Food donations do not count as volunteer hours, but are greatly appreciated.
